

# Tenbury Wells Flood Risk Management Scheme (FRMS) - January 2021 Update

## Sharing information with you

We want to make sure that the community is engaged with the project and kept informed of progress. Due to Coronavirus (COVID-19) restrictions, we are still unable to undertake face to face consultation. The key next steps for the project are;

- Ground investigation and site survey work, due to start in early 2021
- Ecological and environmental surveys planned for Spring 2021
- Ongoing design of the scheme, including more detailed engineering and landscaping designs, in preparation for a planning application in 2021
